SPONSORSHIP TERMS & CONDITIONS

1. CANCELLATION POLICY: PAYMENT FOR SPONSORSHIP IS DUE NO LATER THAN DECEMBER 18, 2009. Failure to pay fees by the due date shall be considered a material breach of the agreement and may result in cancellation of the sponsorship contract. Upon such breach, sponsor shall forfeit its payment and NAILBA reserves the right to assign or resell forfeited sponsorship(s) to other companies.

Requests for cancellation and refunds must be made in writing. NAILBA will retain 50% of the total agreement value as a fee for cancellations received on or before December 18, 2009. NAILBA will retain 100% of the total fee of the sponsorship contract for cancellation requests received after January 1, 2010. The total fee for the sponsorship is non-refundable after January 1, 2010 as indicated above. NAILBA shall not be liable for any interest on any amount refunded.

2. BADGE/ADMITTANCE: Admission to the event will be by official NAILBA registration badges only, which must be worn at all times. Badges are nontransferable and must be worn by the person whose name is on the badge. Sponsoring companies receive one (1) complimentary badge for their **senior level executive (i.e. CEO, CFO, President, etc)**. Please note that the registration for this event will be strictly controlled for **SENIOR LEVEL EXECUTIVES ONLY**. Any registrations that do not meet the criteria for this Senior Level to Senior Level Executive Event may be rejected. Also note: This contract is **NOT** your registration application. You must still register for this event to be able to attend.

3. PHOTOGRAPHY / VIDEOTAPING: Photography and videotaping are prohibited without the written permission of NAILBA.

4. NAILBA RULES/REGULATIONS: NAILBA will not be bound to any verbal agreements, representations, or statements between sponsors, staff, and/or any other parties unless confirmed and signed in writing by the Show Managers (NAILBA).

5. OFFICIAL SPONSOR REPRESENTATIVE: By signing this contract, incorporating these terms by reference, the sponsor agrees to abide by these rules and regulations, and by the decisions of NAILBA. This contract will also become binding on both the Sponsor and the Association upon its acceptance by the Association or Show Managers.

6. NAILBA EVENT DISCLAIMER: The NAILBA event is open to all business entities that provide goods and services to NAILBA member agencies and meeting the criteria established by the Board. NAILBA does not endorse nor evaluate the products or services of the Show sponsors, unless part of an authorized NAILBA partner program. Therefore, the fact that a business entity sponsors at a NAILBA event should not be considered as an endorsement by NAILBA of the products or services of that sponsor.

7. ATTENDEE LIST: Sponsors will be issued a one-time-use pre-show and post-show list for marketing purposes. Abuse of this one-time only rule may result in expulsion from future NAILBA events.

INDEMNIFICATION:

Sponsor hereby agrees to indemnify, save and hold harmless NAILBA and its subsidiaries, affiliates, related entities, partners, agents, officers, directors, employees, attorneys, heirs, successors, Hargrove, the Hotel and assigns, and each of them, from and against any and all claims, actions, demands, losses, damages, judgments, settlements, costs and expenses (including reasonable attorneys' fees and expenses), and liabilities of every kind and character whatsoever, which may arise by reason of: (i) any act or omission by Sponsor or any of its officers, directors, employees, or agents; (ii) any use of Sponsor's name, logo, Web site, or other information, materials, products, or services provided by Sponsor; and/or (iii) the inaccuracy or breach of any of the covenants, representations and warranties made by Sponsor in this Agreement. This indemnity shall require the payment of costs and expenses by Sponsor as they occur. NAILBA shall promptly notify Sponsor upon receipt of any claim or legal action referenced in this Section. The provisions of this Section shall survive any termination or expiration of this Agreement.
